The newly-established Institute of Climate Studies of the Federal University of Espirito Santo invites interested parties to apply for the selection process for the granting of a postdoctoral fellowship linked to the Postgraduate Program in Environmental Engineering financed through Technical and Financial Cooperation No 002/2018 - VALE-ITV / UFES / FAPES-Climatology (Process No 81382545/2018), under the terms established herein.

1. Objectives

The recently created Institute of Climate Studies of the Federal University of Espirito Santo invites interested parties to apply for the selection process for the granting of a postdoctoral fellowship linked to the Postgraduate Program in Environmental Engineering financed through Technical and Financial Cooperation No 002/2018 - VALE-ITV / UFES / FAPES-Climatology (Process No 81382545/2018), under the terms established herein

2. Candidate requirement

PhD obtained in the last 10 years in natural, or social, or health sciences or engineering on themes related to climate science, climate change science or environmental sciences.

3. Research Line of the Institute for Climate Studies and demanded profile of the candidate postdoctoral fellowship senior

Research lines: modelling of the climate system, modelling of the terrestrial system, future scenarios of climate change; observations of extremes and climatic variability and causes attribution studies; impacts of climate change on water resources, agriculture, forestry, biodiversity, infra-structure, health, coastal zones, oceans, energy and natural disasters, and vulnerability and adaptation studies; climate change mitigation.

Profile of Candidate: Doctorate in the areas of Natural Sciences, Health Sciences, Social Sciences or Engineering, with capacity to act on research topics directly related to Climate Change. It is compulsory to have English proficiency (reading, writing and speaking).

- a. PhD obtained in the last 10 (ten) years on the date of hiring the scholarship, currently evaluated by CAPES and recognized by the CNE / MEC. In the case of a diploma obtained in a foreign institution, it must be analyzed by the Coordination of the Institute of Climate Studies / UFES
- b. be compliant with FAPES;
- c. curriculum vitae registered on the Lattes platform;
- d. not having an employment relationship of any nature on the date of hiring the scholarship; not be retired or in a similar situation;
- e. not accumulate any scholarship;
- f. be compliant with federal, state and municipal FAZENDA;
- g. to be compliant with the Labor Court;
- h. be Brazilian or a foreigner with a visa in the country that allows you to work on the date of the scholarship contract;
- i. To present research history and list of publications compatible with the area of interest and lines of research presented in item 3 of this Calling.
- j. To present, at the time of registration, all the documentation listed in item 9 of this Calling.

6. Number of Scholarship

A postdoctoral fellowship of the Technical and Financial Cooperation No 002/2018 - VALE-ITV / UFES / FAPES-Climatology (Process No 81382545/2018) to be implemented from July 2018 to the Institute of Climate Studies / UFES. The scholarship consists of the payment of monthly fees of R\$ 7,000.00 (seven thousand Brazilian Reais) directly to the scholarship holder.

7. Duration of the Scholarship

The duration of the scholarship will be 36 (thirty-six) months.

8. Documents necessary to application:

- a) Registration form - Annex I Form FAPES 2X of the Calling FAPES 009/2014
- b) Copy of the diploma of doctorate from an official institution, national or foreign, or official document of the institution attesting the condition of doctor
- c) Copy of the full version of the Lattes curriculum
- d) Copy of RG and CPF, or National Driver's License. If foreign, copy of Passport

9. Application procedures

9.1. For application, all documents indicated by item 8 must be sent in digital format, within the deadline defined in the schedule (item 5), to the email address proreitor.prppg@ufes.br

9.1.1. It is the candidate's responsibility to ensure that the documents have been fully received by the Secretariat of the Institute for Climate Studies / UFES

9.1.2. The sum of e-mail attachments cannot exceed 7 MB

9.2. It will be considered only applications that arrive at the Secretary of the Institute of Climate Studies by the deadline defined in this Calling and containing all the documents listed in item 8

9.3. The result of the approval of the registrations will be announced on the PPGEA web page, according to the schedule presented in item 5

Curriculum Vitae

Academic performance and production will be evaluated over the last 10 (ten) years (2008 to 2018), as reported in the Curriculum Lattes. The information provided will be subject to the conference by the selection committee.

The candidate CV will be evaluated with a grade ranging from 0-10. To be approved the candidate must have a minimum grade equal to 7 (seven).

10.2. Second Stage

Interview with the candidate.

The candidate's knowledge and ability to scientifically discuss the research lines listed in item 3 will be evaluated, focusing on climate change research.

The interview will be evaluated with a grade ranging from 0-10. To be classified the candidate must have a minimum grade equal to 7 (seven).

10.3 – Results

The final result will be the arithmetic average of the grades obtained in the evaluation of the Lattes Curriculum and in the interview. The results of each stage will be published on the website <http://www.ct.ufes.br/PPGEA>

10.3.1 The final result of the selection will be homologated by the Institute of Climatic Studies / UFES and published in the electronic page in the Secretariat of the PPGEA;

10.3.2 Candidates will be listed in descending order of the final grade, being the first on list the holder and the following alternates.

11. Implementation of the scholarship

11.1. The candidate first classified must appear until the 15 hours of the day 22 June 2018 with all the documents requested in the items below

a. Form of Scholarship Registration in the Country (Annex IV of the FAPES 009/2014 Calling), in 05 (five) ways, fully completed, initialed on all pages and signed by the coordinator of the graduate program, by the supervisor and the scholarship holder

b. Form FAPES 3E - Application for the implementation of a scholarship and declaration of the scholarship holder, fully signed by the scholarship holder and the supervisor (Annex V of the FAPES Notice 009/2014);

- c. Negative or positive certificates with a negative effect of the holder at the federal, state and municipal treasure.
- d. Negative Certificate of Labor Debt;
- e. if you are a foreigner, in the country that allows you to act as a scholarship holder;
- f. proof of residence of the scholarship holder, certifying domicile in the state of Espírito Santo, Brazil;
- g. copy of scholarship holder and supervisor's curriculum Lattes;
- h. copy of the doctoral degree diploma
- i. copy of RG and CPF of the scholarship holder and supervisor
- j. work plan in the format of Form FAPES 2V - research and development project (Annex II of the FAPES 009/2014 Notice).

11.2. If the required documents are not delivered within the period specified in item 12.1, the next classified candidate will be called.

12. Final provisions

12.1. The right to challenge the terms of this Calling shall not be given to those who, having accepted it without objection, shall point out, after the deadline for submission of proposals, any flaws or imperfections, in which case their communication will not have recourse effect

12.2. This Calling may be revoked or annulled, in whole or in part, for reasons of public interest or legal requirement, without implying the right to indemnity or claim of any kind.

12.3. The missing cases, any doubts of interpretation of this Calling will be settled by the Selection Committee of the PPGEA.
